## PAYMENTS TO OPTOMETRISTS PROVIDING ENHANCED OPTOMETRY SERVICES

We have reached agreement with Optometry Wales on the payments eligible to optometrists providing the Wales General Ophthalmic Services (WGOS) Enhanced Optometry Services for 2024-25. The Cabinet Secretary for Health and Social Care has approved these recommendations which are set out below.

The new payment structure outlined in Table 1 becomes operational from 21 October 2024 and relates to the arrangements set out in The Eye Health Examination Service Committee (Wales) Directions 2016 and The Low Vision Service Committee (Wales) Directions 2016, as amended by the National Health Service (Wales Eye Care Services) (Wales) Directions 2023.
